कार्यालय आदेश/OFFICE ORDER NO.02 (MA) of 2025

Reference is invited towards para (5) of the Regional Office Order No. 25(MA) of 2024 dated 14.08.2024 regarding Annual General Transfer for the 'Transfer Year-2024' in the cadre of Nursing Officer vide which grievances through proper channel (through email), were called from the concerned officers with regard to their transfer/posting in the aforesaid orders.

Competent Authority, on the recommendations of 'Transfer Grievance Redressal Committee' with the approval of Medical Commissioner, Head Quarters had considered and disposed of the grievances received through proper channel (through email) from the officers in the above cadre. Accordingly, following is ordered:

- (A) The officer mentioned at Sl.No.11 of Officer Order No. 25(MA) of 2024 dated 14.08.2024 has been granted extension till 28.02.2025 at their present place of posting. They shall, accordingly, be *stand* relieved on 28.02.2025 (A/N) by their Controlling Officer/Head of Office with the direction to report at their ordered place of posting in terms of referred transfer orders.
- (B) Transfer Order in respect of officer mentioned at Sl.No. 48 of Office Order No. 25(MA) of 2024 dated 14.08.2024 stands cancelled.
- (C) The officers mentioned at Sl. No. 1, 2, 6, 9, 10, 12, 15, 16, 17, 18, 19, 20, 21, 23, 24, 25, 27, 28, 30, 31, 32, 35, 37, 39, 40, 41, 46, 49, 50, 54, 74, 106 & 110 have been allowed for retention up to 31.03.2025 at their present place of posting on the ground of their children appearing in Xth/XIth/academic reasons for the academic session 2024-25 subject to proper verification of relevant documents by concerned Head of Office/Controlling Officer. After such verification, if found bona fide, they shall, accordingly, be relieved by respective Head of Office/Controlling Officers on 31.03.2025(A/N) or till the end of session

whichever is earlier, with the directions to report at their ordered place of posting in terms of referred transfer orders.

In addition to above, any other eligible case falling under aforesaid category of children appearing in Xth/XIIth/academic reasons for the academic session 2024-25 may be retained at their present place of posting in terms of clause (3) of Office Order No. 25(MA) of 2024 dated 14.08.2024 under intimation to this office.

(D) Relieving of officer mentioned at Sl.No.26 of Office Order No. 25(MA) of 2024 dated 14.08.2024 is kept on hold for the time being till further orders.

All officers transferred under Office Order No. 25(MA) of 2024 dated 14.08.2024, except the officers detailed in para (A), (B), (C) & (D) above, shall *stand* relieved from their present place of posting with immediate effect, if not relieved earlier, by their Controlling Officers/Head of Office with the direction to report at their ordered place of posting in terms of aforesaid Office Orders.
