1. The regular promotion of aforesaid officials will take effect from the date of assumption of charge to the promoted post.
2. The pay of aforesaid officials on promotion shall be fixed in the Level-6 (Rs.35,400-1,12,400) as per 7th CPC under the normal rules as per provisions of FR 22(I)(a)(i). The promotees shall exercise the option for fixation of pay, if any within one month from the date of issue of this order.
3. The promotion on regular basis in respect of the above officials is subject to such terms and conditions of service as are applicable to similar class of employees and as laid down in the ESIC (Staff & Conditions of Service) Regulations, 2023, as amended from time to time.
4. The seniority in respect of promoted officials in the cadre of Assistant/Head Clerk will be determined in accordance with the rank assigned to them by the DPC as

per the instructions. It may be noted that in case of non-acceptance of this promotion, the same would be offered to their juniors. In that event, such juniors may start drawing higher pay and other benefits for which the seniors who have refused promotion, will not be entitled to any relief in future.

5. The promotion shall be subject to further orders which may be passed by the Hon'ble Supreme Court in SLP(C) No.30621/2011.
6. The aforesaid officials are for the time being promoted on *in situ* basis at his/her present place of posting and is liable for transfer across Karnataka as per administrative requirement/feasibility.
